Eligibility Requirements

In order to participate in the Sweepstakes, an individual must be: (a) a legal resident of the United States, and (b) over the age of 21.

The following individuals are ineligible to participate in the App and/or to receive a gift or prize: (a) employees, officers, directors of Lattner Entertainment or Boyd Gaming Corporation, including subsidiaries and affiliated companies and the members of their immediate families (spouses and parents, siblings, children and their spouses and in-laws) and persons living in the same household with such individuals; (b) owners, managers, officers and employees of participating licensed video gaming locations at their own location and/or location where they work; (c) individuals who have entered any self-limited or government agency self-exclusion program or have been otherwise excluded from casinos by a government agency, Lattner Entertainment, or Boyd Gaming or one of its affiliates; and, (d) persons on a Disassociated Patrons, Self Limit, Involuntary Exclusion, Voluntary Exclusion or Self Exclusion List in jurisdictions which Lattner Entertainment or Boyd Gaming Corporation operate, or who have been otherwise excluded from a participating property.

How to Enter

Option 1 (the Lattner Rewards App):

Participants may enter through enrollment in the Lattner Entertainment Lattner Rewards App (the “App”). Once a participant has completed the enrollment and email verification, the participant can visit a participating Lattner Entertainment licensed video gaming location to enter the Sweepstakes. Participants must enter the beacon area located within a participating establishment and have Bluetooth enabled on their smartphone. The participant then must select the participating location in which they are present and manually select the “Check-In” button to earn an entry.





After entering in the beacon area and selecting the “Check-In” button, the participant will then receive an inbox message to let them know they have earned an entry. Each confirmed “Check-in” earns one entry into the Sweepstakes.

An additional entry into the Sweepstakes will be awarded through the App for each “Check-In” at a participating property, limit one entry per location per calendar day. The number of entries is automatically tracked within the App; however, the location does not have the ability to manually lookup the number of Participant entries.

Each successful entry will be added to all future drawings within the Sweepstakes.

Option 2 (Mail-in Entry):

No purchase necessary to enter or participate. A purchase will not affect your chances of winning.

A participant may enter the Sweepstakes by mailing a handwritten, signed postcard conforming to the U.S. Postal Service guidelines (stated here: <https://pe.usps.com/businessmail101?ViewName=Cards>), with the following information: full legal name, phone number, mailing address, email address, participating location name and address at which they wish to enter the drawing at, and by stating: “I am a legal resident of the United States, I am over the age of 21, and I accept the terms and conditions of the Sweepstakes Rules for the Lattner Entertainment Lattner Rewards App” to: 4003 Tyler Dr., Ottawa, Illinois 61350. Each mail-in entry is good for one (1) chance.

No mechanically reproduced mail-in entries are allowed and any use of robotic, automatic, programmed or the like entry methods will void all such entries by such methods. Lattner Entertainment is not responsible for (i) late, lost, illegible, misdirected, damaged, incomplete, improperly submitted, undeliverable or otherwise irregular Sweepstakes entries; (ii) theft, destruction, unauthorized access to or alterations of entry materials; or (iii) phone, electrical, network, computer, hardware, software program or transmission malfunctions, failures or difficulties.

Participants that submit mail-in entries (Option 2) will be added to the drawing pool as an internal customer account and their information submitted will be stored accordingly. If a mail-in entrant would like to sign up as a mobile app customer in the future, a password reset will be required.

A participant may submit a maximum of one entry per participating location per calendar day, either through Option 1 or Option 2.





How and When Winners will be Selected and Notified

Winners will be selected by random drawing. Winners will be notified via push notification (if enabled) and within the inbox message of the App, or by the phone number and email provided for mail-in entrants.

Once a participant wins a prize, the participant's winning drawing entry is removed from the pool of drawing entries for that specific prize. Any remaining entries the participant has will remain eligible for the other remaining prizes during the promotion period. If the participant wins a subsequent prize, the corresponding drawing entry will be removed from the eligible pool as well.

Prize Descriptions

Claiming a Prize

In order to claim a prize a Participant must:

- For App Users
 - Have the unclaimed, non-expired prize in their My Rewards page;
 - Have location services enabled (always allow or allow while using) in the App;
 - Be at participating property associated with the prize and identify the participating property at which the participant is redeeming their prize in the App;
 - Allow the participating location employee to press REDEEM; and
 - Provide a valid government photo ID that matches the participant's information in the app to claim prize.

- For other Participants
 - Have the unclaimed, non-expired prize in their email inbox;
 - Respond to that email providing the requested information, including a valid government photo ID that matches the information provided on the participant's entry;
 - Identify the location at which the Participant is redeeming their prize; and
 - Follow specific instructions coordinated by a Lattner Entertainment team member for claiming the prize.

Failure to perform any of the above steps may result in the loss of the prize. Neither Lattner Entertainment nor any location is responsible for loss of prize or required to remedy any loss of prize due to failure to comply with the steps above.

- Prize Expiration: Sweepstakes Prizes will have a 30-day redemption period in which they must be claimed. Participants must claim their prize within 30 days of notification. Failure to claim the prize within the 30-day time period will result in the loss of prize. Prize Forfeiture; No Redraws

The prize will be forfeited if the selected winner: (i) cannot be contacted, (ii) does not claim the prize within 30 days after notification, (iii) does not complete the required Affidavit/Release, (iv) fails to comply with these Sweepstakes Rules, or (v) cannot accept or receive the prize for any reason. In the event of a prize forfeiture, no redraw will be conducted and no alternate winner will be selected.



Term of Sweepstakes

The term of the Sweepstakes begins with the entry period listed in the Sweepstakes Description section above. All mail-in entries must be postmarked on or before the final date of the entry period above to be valid. Participants will be randomly selected to receive the prizes detailed above. Participants will be notified, at no expense to them, within fifteen (15) days after the close of the Sweepstakes.

- Limit one entry per participating location per calendar day.
- Sweepstakes entries earned only apply to a particular drawing and cannot be carried over into subsequent Sweepstakes drawings.
