### ELIGIBILITY RULES

1. HORSES OVER THE AGE OF ELEVEN WHICH DID NOT WIN A RACE THE PREVIOUS YEAR WILL NOT BE ALLOWED TO RACE AT DELTA DOWNS.
2. MAIDENS OVER THE AGE OF SIX YEARS OLD WILL BE ALLOWED TO RACE ONLY IF THEY HAVE FINISHED 4TH OR BETTER IN ONE OF THEIR LAST FIVE STARTS.
3. ALL HORSES MUST HAVE A NEGATIVE COGGINS & PIROPLASMOVIS TEST TO BE ELIGIBLE FOR A ZERO DATE WHICH IS (APRIL 10, 2025). FOAL CERTIFICATES WILL NOT BE ACCEPTED ON HORSES THAT ARE NOT TATTOOED.

No Pets allowed.  
Do not ship without confirmation.  
Current Coggins & Piroplasmosis Test required.  
No substitutions without approval.

# READ CAREFULLY

Prior to entering the State of Louisiana, Horses must have a current Veterinarian Health Certificate and have a negative Coggins & Piroplasmosis Test.

## Conditions of Permit to Stable Horses at Delta Downs Racetrack Casino and Hotel

1. Delta Downs reserves the right to refuse the application for stable space in whole or in part or refuse the acceptance of any entry into any race for any reason or cause and without notice to the undersigned.
2. The rules and regulations of the Louisiana State Racing Commission (LSRC) and Delta Downs shall govern this meeting and all parties shall abide by such. All disputes will be decided by Delta Downs or the Stewards of the meet as the case may be, and such decisions upon all points shall be final.
3. Applicant agrees to enter and race all horses which have been granted stall space at Delta Downs, in all races for which they are eligible unless the Racing Secretary agrees otherwise. Any Trainers not abiding by this may be asked to vacate any or all stalls. Fitness to race shall be determined by the track vet or the state vet. In accepting stalls, Applicant agrees to stable at Delta Downs for the entire meet.
4. Applicant agrees that horses will remain only in the stalls that have been allotted, and that the loaning of vacant stalls is prohibited without exception. All empty stalls must be turned in to the Delta Downs Stall Superintendent.
5. Applicant agrees to keep stalls, stable area, and tack rooms clean and in good condition. Applicant also agrees to put manure in the manure bins and to keep the manure bin area clean and free of debris. In addition, Applicant agrees to strip all stalls assigned of all bedding material prior to vacating of stalls. A charge of \$25.00 per stall may be charged if stalls are not cleaned and raked to the satisfaction of Delta Downs.
6. Applicant agrees to deposit \$100.00 for each tack & feed room. If tack rooms & feed rooms are found to be in good condition prior to departure, Delta Downs will refund the deposit to the applicant. There will be a charge of \$50.00 for lost room keys. Any damages to the barn area or the tack rooms & feed rooms will be repaired at the expense of the applicant.
7. Applicant agrees that any alterations (drilling holes, nails, painting, attachments of any kind, etc.) to the tack room, feed rooms, barn or barn area must be approved by the Stall Superintendent. Applicant also agrees that any heating, cooking, cooling, or electrical devices must be approved by the Stall Superintendent. All box fans must be approved by the Stall Superintendent and equipped with protective guards.
8. Applicant agrees (A) to be familiar and make employees familiar with the LSRC rules of racing, the rules of Delta Downs, and the racing officials of the meet; (B) to comply, and require employees to comply with LSRC rules, the rules of Delta Downs, and the decisions of the LSRC, Delta Downs, and the racing officials of the meet; (C) to vacate stalls and move all horses, equipment and personnel off of the premises of Delta Downs within 48 hours of being requested to do so.
9. Hurricane Evacuation Notice: In the event Delta Downs is mandated to evacuate the area by Calcasieu Parish Officials all horses and backside personnel will also be required to vacate the backside once notified within 24 hours or otherwise instructed.
10. All horses stabled at Delta Downs must be eligible to race at Delta Downs, with the exception of approved pony horses.
11. No dogs or other animals allowed in the barn area.
12. No firearms will be allowed on the property of Delta Downs.
13. All owners, trainers, jockeys, and stable employees must be licensed by the LSRC.
14. Delta Downs assumes no responsibility for any foal certificates or silks left for more than seven (7) days after the meet ends.
15. All hoses must be equipped with automatic shutoff nozzles.
16. No personal walking wheels will be allowed on track. Walkers may be leased at the track.
17. All horses stabled at Delta Downs must have a current health certificate dated within 30 days and a current Coggins test dated within 12 months, also a negative Equine Piroplasmosis (EP) test for Theileria equi taken within the past 12 months, prior to entering the confines of a racetrack or race in Louisiana. Additionally, each horse seeking entrance to the stable area must have a Certificate of Veterinary Inspection (CVI) issued by a licensed accredited veterinarian within 30 days of arrival at the track stating the horses temperature (101.5 F or less) and a record of vaccination for Equine Herpes Virus Type 1 (EHV1) administered not less than 14 days but no more than 90 days prior to arrival. Date of vaccination and specific product used must be noted on the CVI.
18. Applicant is responsible for ensuring that all of its respective employees have proper documentation verifying legal status and employability in the United States of America. By signing this agreement, applicant agrees to indemnify, defend and save the Property (including officers, directories, employees and agents of the property) harmless for, from and against any and all claims, suits and liabilities based on the legal status of its employees.
19. Applicant agrees that neither Delta Downs nor any of its officers, employees, or agents shall be liable for any loss, damage, death, or injury of any kind to applicant or applicants employees, agents, invitees, jockeys, or members of any of their respective families, or to any of the property or animals, regardless of whether such injury, loss, death, or damage is caused by a condition of the premises and/or any negligent act or omission of Delta Downs or any of its officers, agents, or employees or from any other cause. Applicant hereby specifically and knowingly assumes all risk of such injury, loss, death, or damage fully and completely.
20. Applicant shall indemnify and hold harmless Delta Downs, its' officers, employees, and agents from any and all liabilities, claims, and demands or damages, injuries, death, loss, cost, or expense, any claim or suit which may arise out of or in connection with or relative to the foregoing and shall pay all attorneys fees and expenses in connection therewith.
21. Notwithstanding any provisions of paragraphs 19 and 20 of this Agreement to the contrary, Applicant may elect to substitute the following provisions in lieu of paragraphs 19 and 20 hereof and such shall govern from the receipt by Delta Downs of written notice by certified U.S. Mail of such election by Applicant.
22. For all personal stabled or racing at Delta Downs the Delta Downs barn area falls under the Federal Environmental Protection Agency's mandated Concentrated Animal Feeding Operations (CAFO) regulations involving animal waste, drainage from barns, manure bins and handling of waste products. Violations of these regulations can result in significant fines and penalties up to and including closure of the racetrack. Examples of violations include, but are not limited to, removal of drain cover or the drain caps at the rear of the wash racks and the discarding of any trash or bedding materials outside of wash racks. All other trash collected from the wash rack must be put in trash receptacles provided. All manure and bedding must be contained inside the enclosed manure bin behind the installed metal curb. Anyone in the barn area disregarding the instructions contained therein or in any way tampering, altering or manipulating the drainage system will be subject to permanent eviction from the property as well as subject to reimburse the property for any and all fines on it by the EPA or other regulatory agencies. Should you have any problems complying with these directives you are required to immediately inform Track Management.
23. Any Trainer or Owner based at Delta Downs who sells a horse for slaughter that was previously stabled at Delta Downs will have their stalls permanently revoked.

Together with foals certificates, Applicant shall file with the Racing Secretary's Office certificates of insurance from insurers acceptable to Delta Downs showing that the Applicant is the named insured on (a) a commercial general liability insurance policy having minimum limits of not less than \$500,000 for personal injury and property damage and (b) a worker's compensation policy issued thru the LHBPA. Such policies shall provide coverage for Delta Downs entire live race meet and shall provide a clause providing that such policies shall not be cancelled without at least thirty (30) days prior written notice to Delta Downs by certified mail. No policies may cover more than one trainer.
