

## FanDuel Year of Wins Promo 2026 (Louisiana)

### **OFFICIAL RULES**

#### **1. Description of Sweepstakes**

Welcome to the FanDuel Year of Wins Drawing 2026 (Louisiana) (the “**Sweepstakes**”), where participants who enter the Sweepstakes via the Wager Method of Entry (as defined below) or the Alternate Method of Entry (as defined below) during the Sweepstakes Period (as defined below) will earn an entry into the Sweepstakes for a chance to win fifty-two (52) \$100 bonus bet vouchers for use only at an Eligible Retail Location (as defined below), \$5,200 in total bonus bet vouchers as described in Section 5 below.

The Sweepstakes is sponsored by Betfair Interactive US LLC (“**FanDuel**” or “**Sponsor**”), located at 9000 Wilshire Blvd., 2nd Floor, Beverly Hills, CA 90211. The terms “**you**” or “**your**” mean the person who participates in this Sweepstakes. Participation in the Sweepstakes is expressly conditioned upon acceptance of and compliance with all of these Sweepstakes “**Official Rules**.” Sweepstakes participants may be required to sign paperwork issued by Sponsor.

#### **2. Sweepstakes Period**

The Sweepstakes will begin on 12:00 a.m. Eastern Time (“**ET**”) on January 10, 2026, and all entries must be received by Sponsor by 11:59 p.m. ET on February 08, 2026 (the “**Sweepstakes Period**”).

#### **3. Eligibility**

The Sweepstakes is only open to individuals who, at the time of entry, are at least twenty-one (21) years of

age, are physically present in the State of Louisiana and otherwise comply with these Official Rules. Employees, officers and directors of Sponsor or Boyd Gaming Corporation, and each of their parent companies, affiliates, cable/satellite affiliates, advertising and promotion agencies, retailers, prize providers, distributors (collectively, "**Sweepstakes Entities**"), and each of such employees', officers' and directors' immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to participate in the Sweepstakes or receive the Prize (as defined below). For purposes of this Sweepstakes, "**immediate family members**" are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and "**those living in the same household**" shall mean people who share the same residence at least three (3) months a year, whether legally related or not. A person cannot be an eligible participant or winner if such person is a person: (i) with whom U.S. persons or entities are restricted from doing business under regulations of the Office of Foreign Asset Control ("OFAC") of the Department of the Treasury (including those named on OFAC's Specially Designated and Blocked Persons List) or under any statute or executive order; or (ii) who is acting, directly or indirectly, for or on behalf of any such person. Void outside of the State of Louisiana and where prohibited by law. **Any individuals who are actively on any "exclusion" or "self-exclusion" list(s) are ineligible to participate in this Sweepstakes. Individuals who have entered any self-limited or government agency self-exclusion program or have been otherwise excluded from casinos by a government agency, Boyd Gaming Corporation, Sponsor or one of their affiliates or gaming license partners and persons on a Disassociated Patrons, Self-Limit, Involuntary Exclusion, Voluntary Exclusion or Self Exclusion List in jurisdictions which Boyd Gaming Corporation, Sponsor or their affiliates or gaming license partners operate are not eligible to participate in the Sweepstakes or receive the Prize.**

#### **4. Action Required**

To participate in the Sweepstakes, during the Sweepstakes Period, there are two (2) methods of entry and eligible participants may enter via either method of entry.

- **Wager Method of Entry:** To enter the Sweepstakes by wagering, during the Sweepstakes Period, eligible participants must enter the Eligible Retail Location, swipe your Boyd Rewards loyalty card, and place a retail-only Same Game Parlay or Same Game Parlay Plus real money wager with odds of +250 or greater, totaling at least twenty dollars (\$20) on any Eligible Game(s) (as defined below) offered at the FanDuel Sportsbook at Amelia Belle Casino at 500 Lake Palourde Rd, Amelia, LA 70340, or the FanDuel Sportsbook at Sam's Town Hotel & Casino Shreveport at 315 Clyde Fant Pkwy, Shreveport, LA 71101, or the FanDuel Sportsbook at Evangeline Downs Racetrack & Casino at 2235 Creswell Ln, Opelousas, LA 70570, or the FanDuel Sportsbook at Treasure Chest Casino at 4540 Williams Blvd Kenner, LA 70065, or the FanDuel Sportsbook at Delta Downs Racetrack at 2717 Delta Downs Dr, Vinton, LA 70668 (the "**Eligible Retail Locations**" and each an "**Eligible Retail Location**"). Completion of the foregoing steps is collectively referred to herein as the "**Wager Method of Entry**." Wagers that are settled using the "Cash Out" feature will not be deemed to satisfy the Wager Method of Entry. Separately, and to the extent applicable, wagers placed using site credits, bonus bets, profit boost tokens or any bonus received from a separate Sponsor promotion will not be deemed to satisfy the Wager Method of Entry.

- **Alternate Method of Entry:** To enter the Sweepstakes without wagering, eligible participants must complete the mail in entry below. Completion of the foregoing steps is collectively referred to herein as the **“Alternate Method of Entry.”**

1. Legibly handwrite your full name, complete mailing address (including city, state, zip code, email address (preferably one associated with FD account if available), the Sweepstakes name, the specific Eligible Retail Location your Entry should be connected to (this determines where each Weekly Prize can be redeemed), and date of birth on a standard size piece of paper.

**Important Notes:**

- All mail-in entries must be postmarked by February 8<sup>th</sup>, 2026, and received by February 10<sup>th</sup>, 2026.
- Each valid mail-in entry will be considered for the sweepstakes.

Participants who satisfy the Wager Method of Entry or the Alternate Method of Entry will receive one (1) entry into this Sweepstakes (an **“Entry”**) during the Sweepstakes Period. For clarity, entrants who enter via the Wager Method of Entry will earn one (1) Entry for each retail-only Same Game Parlay or Same Game Parlay Plus real money wager with odds of +250 or greater, totaling at least twenty dollars (\$20) on any Eligible Game(s) offered at the FanDuel Sportsbook at an Eligible Retail Location, and entrants who enter via the Alternate Method of Entry will earn one (1) Entry for each mail in entry received. For additional clarity, individuals on any “Self Excluded,” “Timeout” or similar exclusion list (as set in any jurisdiction or on any gambling account, including in the FanDuel Sportsbook app) are ineligible to participate in this Sweepstakes. All Entries must be submitted or postmarked, as applicable, during the Sweepstakes Period, before the Sweepstakes concludes at 11:59 p.m. ET on February 8th, 2026 (**“Lock Time”**) to be eligible for the Sweepstakes. Any Entries submitted after this Lock Time will be ineligible for the Sweepstakes.

There is no limit on number of Entries per person during the Sweepstakes Period, regardless of the method of entry. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor’s sole and absolute discretion. Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and location) are void. All materials submitted become the physical property of Sponsor and will not be returned. In the event of a dispute over the identity of an online entrant, Entry will be deemed submitted by the registered account holder of the email address or username associated with the entry, provided that person is eligible. Winner may be required to show proof of being the registered account holder. **“Registered account holder”** is defined as the person assigned to an email address or username by an internet access provider, online service provider or other organization responsible for assigning email addresses or usernames. In the event a dispute regarding the identity of

the individual who actually submitted an Entry cannot be resolved to Sponsor's satisfaction, the affected Entry will be deemed ineligible. Sponsor's designated database clock will be the official timekeeper for this Sweepstakes. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified. All entrants submitting materials/content as part of the Sweepstakes will be non-exclusively licensing (with the unlimited right to sublicense) to Sweepstakes Entities the right to use such materials, and the images related thereto (including entrant's name, social media account username and likeness), for any purpose (including any and all commercial purposes) with the right to modify the materials and make derivative works thereof. The Sweepstakes Entities may run multiple campaigns, contests, sweepstakes or other promotions simultaneously. Entry into one (1) campaign, contest or sweepstakes does not constitute entry into any other.

## **5. Claiming Sweepstakes Prize/Odds**

Two (2) winners will be selected in a random drawing from all eligible Entries received during the Sweepstakes Period on or around February 11, 2026 (the "**Drawing**"). The winners may receive the following: up to fifty-two (52) \$100 bonus bet vouchers for use only at the Eligible Retail Location your winning Entry was associated with, creating a potential total prize of up to \$5,200 bonus bet vouchers. To be clear, a winner is eligible to redeem one (1) \$100 bonus bet voucher per week at such Eligible Retail Location from February 16<sup>th</sup>, 2026 through February 15<sup>th</sup>, 2027 (each weekly voucher redeemed is a "**Weekly Prize**", and the total Weekly Prizes redeemed are the "**Prize**"). The approximate retail value ("**ARV**") of the Prize is five thousand two hundred dollars (\$5,200). If the actual value of the Prize is less than the stated ARV, the difference will not be awarded.

Subject to verification of eligibility and compliance with the terms of these Official Rules, potential winners will be declared an official "**Winner**" of the Sweepstakes. Upon receiving notification from Sponsor via email to the email address associated with the Winner, the Winner will have seventy-two (72) hours to respond back to Sponsor in the manner specified by Sponsor. The Sweepstakes Entities are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, insufficient space in entrant’s email account to receive email messages or any failed attempts to notify the Winner, and no responsibility is assumed by the Sweepstakes Entities for any correspondence returned as undeliverable or any other problems associated with attempts to notify the Winner. If any potential Winner is found to be ineligible, or if they have not complied with these Official Rules, or if a potential Winner cannot attend or participate in any portion of the Prize, or declines the Prize for any reason prior to award, such potential Winner may be disqualified and an alternate potential Winner may be selected. If, for any reason, more bona fide Winners come forward seeking to claim Prizes in excess of the number of each type of Prize set forth in these Official Rules, the Winner, or remaining Winners, as the case may be, of the advertised number of Prizes available may be selected in a random drawing from among all persons making purportedly valid claims for such Prize. Inclusion in such drawing shall be each entrant’s sole and exclusive remedy under such circumstances.

Odds of winning depend upon the number of Entries received during the Sweepstakes Period. The purchase of any goods or services will not increase any participant’s chances of winning.

Prize recipient will be solely responsible for all federal, state and local taxes, and for any other fees or costs associated with the Prize received, regardless of whether the Prize, in whole or in part, is used. Weekly Prize is non-transferable, with no equivalents or substitutions except at Sponsor’s sole and absolute discretion. All Prize details not specified in these Official Rules will be determined in Sponsor’s sole and absolute discretion. Prize details and availability are subject to change and Prize provider’s rules and restrictions, and in the event that Sponsor is unable to provide the Winner with their Prize, Sponsor may elect to provide the Winner with the approximate value of such item in cash or award an alternate prize of comparable or greater value. Prize is awarded “AS IS” and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). The ARV of the Prize is based on available information provided to Sponsor and the value of any prize awarded to the Winner may be reported for tax purposes as required by law. The Winner may be required to provide Sponsor with a valid Social Security number before any Weekly Prize will be awarded for tax reporting purposes. An IRS Form 1099 may be issued in the name of Winner. An unredeemed Weekly Prize will be forfeited. The Weekly Prize, if legitimately redeemed, will be awarded. The Sweepstakes Entities are not responsible for and will not replace any lost, mutilated or stolen Weekly Prize or any Weekly Prize that is undeliverable or does not reach the Winner because of an incorrect or changed address. If Winner does not redeem or use the entire Weekly Prize, the unredeemed or unused part of the Weekly Prize will be forfeited, and the Sweepstakes Entities will have no further obligation with respect to that Weekly Prize or portion of the Weekly Prize. The Sweepstakes Entities are not responsible for, and Winner will not receive the difference, between the actual value of any Weekly Prize at the time of award and the stated ARV of the Prize in these Official Rules or in any Sweepstakes-related correspondence or material. Limit of one (1) Prize per person in connection with this Sweepstakes.

## **6. Registration Procedures**

In order for the Winner to use any part of the Prize, he/she must be a current member of Boyd Rewards. The Winner may join Boyd Rewards after the Sweepstakes Period if they are not already a member of Boyd Rewards by personally visiting an Eligible Retail Location and speaking with a Sponsor representative. By participating in this Sweepstakes, participants agree to Sponsor's Terms of Use <https://www.fanduel.com/terms> (toggle to "Sportsbook") and Privacy Policy found at <https://www.fanduel.com/fanduel-sportsbook-privacy-policy>. If you do not agree to Sponsor's Terms of Use and consent to Sponsor's Privacy Policy, you cannot participate in this Sweepstakes.

## **7. Limitations on Participation**

In addition to the eligibility requirements in Section 3 above, FanDuel reserves the right to refuse or otherwise restrict your eligibility to participate in this Sweepstakes for any reason, in its sole discretion, including based on your wagering patterns or wagering history or if you failed to take advantage of any previous promotion in good faith. Wagers placed to enter into this Sweepstakes will not satisfy any wager or other promotion requirements for a separate Sponsor promotion. If you are opted into or participating in two (2) or more promotions with wagering requirements, your wagers will count towards the first opted-in promotion or promotion you first participate in. This Sweepstakes is void outside of the State of Louisiana and where prohibited by law. No limit on number of Entries per person during the Sweepstakes Period, regardless of method of entry.

Separately, and to the extent applicable, wagers placed using site credits, bonus bets, profit boost tokens or any bonus received from a separate Sponsor promotion will not be deemed eligible to earn an Entry.

## **9. Order of Funds Used for Wagering**

Each redeemed Weekly Prize must be produced by the Winner when placing wager through the betting window located at the FanDuel Sportsbook at the Eligible Retail Location connected with your Entry.

## **10. Eligible Games**

Any market offered during the Sweepstakes Period at the FanDuel Sportsbook at an Eligible Retail Location (collectively, the “**Eligible Games**”) is eligible to be wagered on in accordance with the Wager Method of Entry to enter this Sweepstakes.
