1. Description of Sweepstakes

Welcome to the FanDuel Ticket Blitz Drawing (the “**Sweepstakes**”), where participants who enter the Sweepstakes via the Wager Method of Entry (as defined below) or the Alternate Method of Entry (as defined below) during an Entry Period (as defined below) will earn an entry into the Sweepstakes for a chance to win a pair of regular tickets to an NFL game of their choice during the 2024-2025 regular season, subject to certain limitations as described in Section 5 below.

The Sweepstakes is presented by Boyd Gaming Corporation and its affiliates and subsidiaries (collectively, “**Boyd**”) and sponsored by Betfair Interactive US LLC (“**FanDuel**” or “**Sponsor**”), at 6701 Center Drive West, Suite 1000, Los Angeles, CA 90045. The terms “**you**” or “**your**” mean the person who participates in this Sweepstakes. Participating in the Sweepstakes is expressly conditioned upon acceptance of and compliance with these Sweepstakes “**Official Rules.**” Sweepstakes participants may be required to sign paperwork issued by Sponsor.

2. Sweepstakes Period

The Sweepstakes will begin at 9:00 a.m. Eastern Time (“**ET**”) on June 6, 2024, and all entries must be received by 11:59 p.m. ET on August 14, 2024 (the “**Sweepstakes Period**”); provided that the Sweepstakes Period will be divided into five (5) time periods during which individuals may enter into the Sweepstakes (each, an “**Entry Period**”):

3. Eligibility

The Sweepstakes is only open to individuals who, at the time of entry, are at least twenty-one (21) years of age, are physically present in the State of Ohio and otherwise comply with these Official Rules. Employees, officers and directors of Boyd, Sponsor and each of their respective parent company, affiliates, cable/satellite affiliates, advertising and promotion agencies, prize providers, retailers, distributors (collectively, "**Sweepstakes Entities**"), and each of such employees', officers' and directors' immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to participate in the Sweepstakes or receive a Prize (as defined below). For purposes of this Sweepstakes, "**immediate family members**" are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and "**those living in the same household**" shall mean people who share the same residence at least three (3) months a year, whether legally related or not. A person cannot be an eligible participant or winner if such person is a person: (a) with whom U.S. persons or entities are restricted from doing business under regulations of the Office of Foreign Asset Control ("**OFAC**") of the Department of the Treasury (including those named on OFAC's Specially Designated and Blocked Persons List) or under any statute or executive order; or (b) who is acting, directly or indirectly, for or on behalf of any such person. Void outside of the State of Ohio and where prohibited by law. **Individuals who have entered any self-limited or government agency self-exclusion program or have been otherwise excluded from casinos by a government agency, Boyd, Sponsor or one of their affiliates or gaming license partners and persons on a Disassociated Patrons, Self-Limit, Involuntary Exclusion, Voluntary Exclusion or Self Exclusion List in jurisdictions which Boyd, Sponsor or their affiliates or gaming license partners operate are not eligible to participate in the Sweepstakes or receive a Prize.**

4. Action Required

To participate in the Sweepstakes, during an Entry Period, there are two (2) methods of entry and eligible participants may enter via either method of entry:

- **Wager Method of Entry:** To enter the Sweepstakes, during an Entry Period, eligible participants must place a **retail-only** real money wager totaling at least fifty dollars (\$50) on any parlay on any games offered at the FanDuel Sportsbook at Belterra Park Cincinnati, at 6301 Kellogg Rd, Cincinnati, OH 45230 (the "**Eligible Retail Location**"). Participants must then fill out and submit all required information through the following form: <http://events.fanduel.com/hometicketblitz>. Completion of the foregoing steps is collectively referred to herein as the "**Wager Method of Entry.**"
- **Alternate Method of Entry:** To enter the Sweepstakes without wagering, during an Entry Period, eligible participants must fill out and submit all required information through the following form: <https://forms.office.com/r/gQsxTPwyQT>. Completion of the foregoing steps is collectively referred to herein as the "**Alternate Method of Entry.**" The Alternate Method of Entry is free.

Participants who satisfy the Wager Method of Entry or the Alternate Method of Entry will receive one (1) entry into this Sweepstakes (an "**Entry**") during the applicable Entry Period. For clarity, entrants who enter via the Wager Method of Entry will earn one (1) Entry for each retail-only bet wagered of at least fifty dollars (\$50) on any parlay on any games offered at the FanDuel Sportsbook at the Eligible Retail Location, and entrants who enter via the Alternate Method of Entry will earn one (1) Entry for each completed form submitted. For additional clarity, individuals on any "Self Excluded," "Timeout" or similar exclusion list (as set in any jurisdiction or on any gambling account, including in the FanDuel Sportsbook app) are ineligible to participate in this Sweepstakes.

No limit on number of Entries per person per Entry Period in this Sweepstakes, regardless of method. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to

age and location) are void. All materials submitted become the physical property of Sponsor and will not be returned. In the event of a dispute over the identity of an online entrant, Entry will be deemed submitted by the registered account holder of the email address associated with the entry or social media account for the domain associated with the submitted address provided that person is eligible. Winners may be required to show proof of being the registered account holder. **“Registered account holder”** is defined as the person assigned to an email address or username by an internet access provider, online service provider or other organization responsible for assigning email addresses or usernames. In the event a dispute regarding the identity of the individual who actually submitted an Entry cannot be resolved to Sponsor’s satisfaction, the affected Entry will be deemed ineligible. Sponsor’s designated database clock will be the official timekeeper for this Sweepstakes. Those who do not follow all the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified. All entrants submitting materials/content as part of the Sweepstakes will be non-exclusively licensing (with the unlimited right to sublicense) to Sweepstakes Entities the right to use such materials, and the images related thereto (including entrant’s name, social media account username and likeness), for any purpose (including any and all commercial purposes) with the right to modify the materials and make derivative works thereof. Entrants represent and warrant that the materials submitted will not infringe or violate any right whatsoever, including, without limitation, any personal rights (e.g., defamation, privacy, false light, moral right, etc.) or any property rights (e.g., copyright, trademark, right to ideas, etc.) of any person or entity and the use thereof will result in no third party liability or obligations. The Sweepstakes Entities may run multiple campaigns, contests, sweepstakes or other promotions simultaneously. Entry into one (1) campaign, contest or sweepstakes does not constitute entry into any other.

5. Claiming Sweepstakes Prizes/Odds

There will be a total of five (5) winners selected in this Sweepstakes: one (1) winner will be selected per Entry Period. Each potential winner will be selected through an electronic random drawing on the dates indicated in the chart in Section 2 above from all eligible Entries received during the applicable Entry Period in accordance with these Official Rules. Each winner will receive two (2) regular tickets to one (1) NFL game during the 2024-2025 regular season of the winner’s choice from a list of games provided by Sponsor in its sole and absolute discretion (the **“Prize”**). The approximate retail value (**“ARV”**) of each Prize is six hundred dollars (\$600), and the total ARV of all Prizes awarded in this Sweepstakes is three thousand dollars (\$3,000). The ARV of the Prizes may vary depending on point of purchase/rate fluctuations. Certain restrictions may apply; please see terms and conditions provided in connection with the tickets. Travel to/from the games associated with the Prizes will not be provided as part of the Prizes in this Sweepstakes. Each Winner and their companion will be solely responsible for all costs/expenses related to attending the games, including any parking fees should the winner and/or their companion choose to drive, unless otherwise stated in the ticket package.

Subject to verification of eligibility and compliance with the terms of these Official Rules, potential winners will be declared the official **“Winners”** of the Sweepstakes. Upon receiving notification from Sponsor via email to the email address associated with the Winners, the Winners will have forty-eight (48) hours or another time period specified by Sponsor to respond back to Sponsor in the manner specified by Sponsor. Notification is deemed to occur upon the sending of an email to a Winner’s email address. If a Winner fails to respond in the manner specified by Sponsor within forty-eight (48) hours or another time period specified by Sponsor, Sponsor reserves the right, in its sole and absolute discretion, to disqualify such Winner and to select an alternate Winner from the remaining qualifying participants. Additionally, Winners will have seven (7) days from Sponsor’s email notification or another time period specified by Sponsor to select the game they wish to receive the tickets to from the list of games provided by Sponsor; if a Winner does not select their game within such a time period articulated by Sponsor, Sponsor reserves the right to disqualify the Winner and select an alternate Winner from the remaining qualifying participants.

The Sweepstakes Entities are not responsible for false, incorrect, changed, incomplete or illegible contact information. A potential Winner may be required to submit an affidavit of eligibility / release of liability / Prize acceptance agreement (collectively, the **“Affidavit”**) and return the Affidavit within the time period specified at notification before being eligible to receive their Prize. If a potential Winner fails or refuses to sign and return such Affidavit within the time period required by Sponsor or if a Prize or Prize notification is returned as rejected, faulty, unclaimed or returned as undeliverable to such potential Winner, such potential Winner may be disqualified, and an alternate may be selected. Non-compliance shall result in disqualification and the Prize will

be awarded to an alternate Winner. The Sweepstakes Entities are not responsible for and shall not be liable for late, lost, damaged, intercepted, misdirected or unsuccessful efforts to notify a potential Winner. The Sweepstakes Entities are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, insufficient space in entrant's email account to receive email messages or any failed attempts to notify a Winner, and no responsibility is assumed by the Sweepstakes Entities for any correspondence returned as undeliverable or any other problems associated with attempts to notify a Winner. If any potential Winner is found to be ineligible, or if they have not complied with these Official Rules, or if a potential Winner cannot attend or participate in any portion of a Prize, or declines a Prize for any reason prior to award, such potential Winner may be disqualified and an alternate potential Winner may be selected. If, for any reason, more bona fide Winners come forward seeking to claim Prizes in excess of the number of each type of Prize set forth in these Official Rules, the Winners, or remaining Winners, as the case may be, of the advertised number of Prizes available may be selected in a random drawing from among all persons making purportedly valid claims for such Prizes. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. Prizes will be delivered to the Winners in a commercially reasonable time after Winner selection, via Ticketmaster. Each Winner will need an active Ticketmaster account to receive their Prize; creating a Ticketmaster account on <https://www.ticketmaster.com> is free.

Odds of winning depend upon the number of Entries received during the applicable Entry Period. The purchase of any goods or services will not increase any participant's chances of winning. Limit of one (1) Prize per person per Entry Period in this Sweepstakes.

If, for whatever reason, a Prize or game associated with any Prize is cancelled after such Prize is awarded, Sponsor's liability for the Prize is limited only to the non-event portions of the Prize. No compensation will be paid in lieu of a cancelled game or event. The tickets to the games are subject in all respect to the terms and conditions set forth on the tickets and any requirements of the facility hosting the event, and Sponsor disclaims any liability in connection with such terms and conditions and requirements, including, but not limited to, any facility or Prize provider restrictions in honoring the tickets associated with the Prize. **Seat locations will be determined by Sponsor in its sole and absolute discretion.** The Winners are strictly prohibited from selling, auctioning, trading or otherwise transferring the tickets unless Sponsor consents in writing. In the event that a Winner (and/or their companion) engages in behavior that (as determined by Sponsor, game venue or any Prize provider in its or their sole and absolute discretion) is obnoxious, inappropriate, threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the applicable experience early. Decisions regarding the conduct of a Winner and guest in all aspects of their participation in any Prize-related game/activity will be in the sole discretion of Sponsor, and any of Sponsor's representatives and final and binding in all respects. A Winner and guest may be removed or disqualified from participating in any aspect of the Prize for any reason at any time, including, without limitation, creating an unauthorized disturbance, interruption or unnecessarily rough physical contact, creating the potential for injury or property damages, or for any unhealthy, unsafe, unlawful or inappropriate act. If any Winner or guest who, in the opinion of Sponsor or any of Sponsor's representatives, is considered a physical or mental threat to the well-being of any other individual, they may be removed from any premises relating to a Prize and the Winner consents to such removal. The Winners and guests must abide by all applicable venue policies including any rules and regulations related to COVID-19.

Prize recipients will be solely responsible for all federal, state and local taxes, and for any other fees or costs associated with the Prizes received, regardless of whether the Prizes, in whole or in part, are used. Prizes are non-transferable, with no equivalents or substitutions except at Sponsor's sole and absolute discretion. All Prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. Prize details and availability are subject to change and Prize provider's rules and restrictions, and in the event that Sponsor is unable to provide any Winner with their Prize, Sponsor may elect to provide such Winner with the approximate value of such item in cash or award an alternate prize of comparable or greater value. The Prizes are awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). The ARV of the Prizes is based on available information provided to Sponsor and the value of any Prize awarded to a Winner may be reported for tax purposes as required by law. The Winners may be required to provide Sponsor with a valid Social Security number before the Prizes will be awarded for tax reporting purposes. An IRS Form 1099 may be issued in the name of a Winner. Any unclaimed Prize will be forfeited. Prizes, if legitimately claimed, will be awarded. The Sweepstakes Entities are not responsible for and will not replace any lost, mutilated or stolen Prizes or any

Prize that is undeliverable or does not reach a Winner because of an incorrect or changed email address, account information or other relevant information. If a Winner does not accept or use the entire Prize, the unaccepted or unused part of the Prize will be forfeited, and the Sweepstakes Entities will have no further obligation with respect to that Prize or portion of the Prize. The Sweepstakes Entities are not responsible for, and Winners will not receive the difference between the actual value of the Prize at the time of award and the stated ARV in these Official Rules or in any Sweepstakes-related correspondence or material.

Wagers placed to enter into this Sweepstakes will not satisfy any wager or other promotion requirements for a separate Sponsor promotion. If you are opted into or participating in two (2) or more promotions with wagering requirements, your wagers will count towards the first opted-in promotion or promotion you first participate in. This Sweepstakes is void outside of the State of Ohio where prohibited by law. Limit of one (1) Prize per person per Entry Period. No limit on number of Entries per person per Entry Period.

Participants entering the Sweepstakes concurrently with wording, depiction or images that Sponsor considers, in its sole discretion, to be vulgar, profane, offensive or otherwise inappropriate shall not be eligible for the Sweepstakes.

12. Cancellation

Cancellations will be prohibited should any part of your wager be live, if odds change on any leg or if the Sweepstakes has concluded.

14. Additional Terms

Administration: Sponsor expressly reserves the right to amend, suspend or terminate this Sweepstakes at any time without prior notice or consent. Administration of this Sweepstakes is at the sole discretion of Sponsor. Sponsor reserves the right to restrict at any time any person from participating in this Sweepstakes for any reason. In the event Sponsor is prevented from continuing with the Sweepstakes by any event beyond its control, including, but not limited to, fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal, state or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each, a "**Force Majeure**" event or occurrence), Sponsor shall have the right to modify, suspend or terminate the Sweepstakes or Prize. of Use (<https://www.fanduel.com/terms>). This Section of the FanDuel Terms of Use requires you to resolve disputes by binding arbitration and you agree to waive the ability to bring claims in a class action format.
